## Summer Showdown - Show Information and Rules

1. Open to in and out of state exhibitors that are in 4-H and FFA. Still in high school.
2. All registration papers must be in the exhibitors name and be shown by the exhibitor.
3. Power is limited. Bring generators if possible.
4. Not responsible for accidents or stolen property.
5. **Entry Fee \$30.00 per head. Must be received by September 7 with entry.**
6. Heifers must be born on or after January 1, 2009.
7. Steers and commercial heifers shown by weight.
8. Purebred heifers shown by breed. Registration papers required for all purebred heifers.
9. Four (4) head required to make a breed class.
10. A.O.B. heifer class will be registered animals not meeting minimum number of head for breed.
11. Breed champion heifers and reserve breed champion heifers will return to compete for the top five overall heifers.
12. The first and second place steers in each class will return to compete for the top five overall steers.
13. Payout is for the top five steers and heifers.
14. This is a Junior show. Please no unethical practices.
15. Judges placing are final.
16. Adequate tie space is available - on a first come first serve basis.
17. Weatherly show supply trailer will be onsite.
18. Bedding material will be available for purchase.
